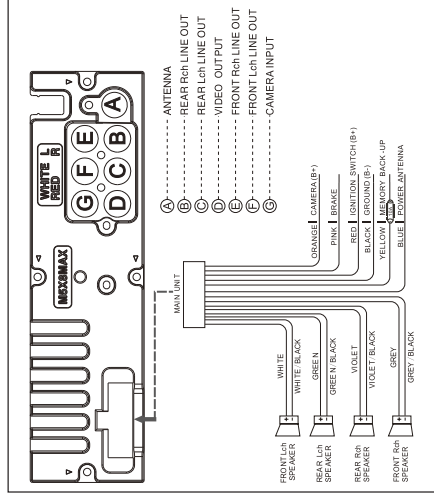
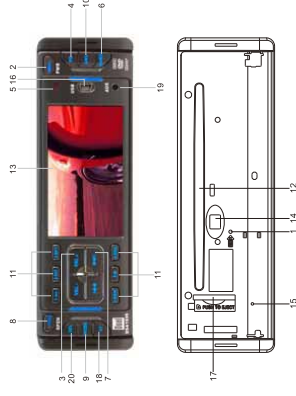


Wiring Diagram – Inputs/Outputs

System Setup

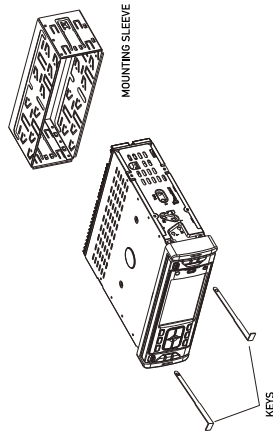
